Our Lady's Grove Primary School has an Information and Technology Acceptable Use Policy in place to ensure that all children benefit from learning opportunities offered by the school's internet and digital media resources in a safe and effective manner.

- I will never access social media sites in school

#### In and Out of school

- I will adhere to the school's Mobile Phone and Electronic Device Policy
- I will never send text messages, emails or comments that are harmful and hurtful to another person
- I will never give out my name, address and/or phone number to anyone online
- I will not share personal information about another person online
- I will always use my Username and not my real name on websites so that I can protect my identity
- I will never arrange to meet in person anyone I meet online
- I will not use my phone to take photos of people without their permission
- I will not upload any photos without getting permission
- My password is my own and I will not share it even with my best friend
- I will never login as someone else
- I will always tell my parents if I receive anything from the internet that makes me feel uncomfortable or threatened
